TEAM WAIVER OF LIABILITY AND RELEASE AGREEMENT
IMPORTANT: PLEASE READ CAREFULLY BEFORE SIGNING**

This Team Waiver of Liability and Release Agreement (“Agreement”) is entered into by the undersigned Team Representative (“Team Head”) on behalf of the team members listed below (collectively, the “Participants”) in favor of Magnum Sports Complex, its owners, officers, employees, agents, contractors, representatives, and affiliates (collectively, the “Facility”).

1. ASSUMPTION OF RISK

We understand that the use of the Facility and participation in sports, training, or recreational activities (collectively, the “Activities”) involve inherent risks, including but not limited to: personal injury, illness, disability, property damage, and even death. Each Participant knowingly and voluntarily assumes all such risks, whether foreseen or unforeseen, and accepts full responsibility for their participation.

2. RELEASE AND WAIVER

In consideration of being allowed access to and use of the Facility and participation in the Activities, the undersigned Team Head, on behalf of the team and its members, hereby releases, waives, discharges, and holds harmless Magnum Sports Complex and all its owners, staff, and affiliates from any and all claims, demands, causes of action, damages, losses, or liabilities arising out of or related to participation in the Activities or use of the Facility, including but not limited to those arising from negligence of the Facility.

3. HEALTH AND FITNESS CERTIFICATION

Each Participant certifies that they are physically fit and have no medical condition that would prevent safe participation in the Activities. It is the responsibility of each individual to consult with a physician before engaging in any physical activity at the Facility.

4. DAMAGE TO PROPERTY

The Team agrees to be responsible for any damage caused to the Facility’s property, equipment, or premises by any of its members, whether intentional or accidental.

5. MINOR PARTICIPANTS

If any Participant is a minor (under 18 years old), their parent or legal guardian must sign below to indicate consent and acceptance of all terms of this Agreement on behalf of the minor.

6. GOVERNING LAW

This Agreement shall be governed by and construed in accordance with the laws of the Republic of the Philippines. Any disputes arising shall be resolved exclusively in the appropriate courts of Cebu City.
